It is the intention of the ECB to appoint a contractor who will provide stationery material to the ECB. Delivery has to be split to supply single ECB staff members with requested material. Delivery takes place either to a central place or directly to one of the three ECB sites in the centre of Frankfurt.
The following services have to be provided: (a) provision of an electronic catalogue in English with visual and written presentation including price, (b) delivery of ordered items, (c) stationery packed and labelled per

requesting staff member, (d) delivery to agreed places on a daily basis, (e) updating of catalogue, (f) provision of reports, (g) customer service function with English as the main communication language.

The hosted system shall be interfaced with the ECB ERP installation at a later date.
