Background



- T2 usage guidelines are shared on MyStandards with the T2 open community as non-binding XSDs typically 8 weeks (except for T2 R2026.JUN) and binding XSDs 9 business days before T2 EAC deployment. 4CB provide a list of MyStandards links to the T2-WG via non-binding XSD delivery mail and via draft T2 EAC release note to support access to changed XSDs allocated to a release.
- In this process, Mystandards users who are no member of the T2-WG rely on:
 - (i) MyStandards search functionality and Business Version of each UG : giving the possibility to all users, including no-T2-WG members, to search for an usage guideline related to a specific release, or
 - direct participants, members of T2-WG, forwarding the list of MyStandards links to stakeholders (direct and indirect participants). Vendors are likely to not benefit from this option.
- While use cases for external users are limited and the MyStandards search functionality is well adapted, it seems that various stakeholders who have access to the T2 STP lack guidance on finding T2 binding XSDs. After delivery of binding XSDs for T2 R2024.NOV on 24.07.2024, stakeholders reached out to 4CB (EMC) through various channels (e.g. MyStandards, email) asking for confirmation about their publication date and how to find them. An example is EBA or participants outside Europe who are not assigned to a Eurosystem central bank (e.g. UBS Singapore).
- Currently, about 2000 active users are registered for MyStandards 'open community' in RTGS, including many email addresses (e.g. from vendors) outside the Eurosystem, which only have little or no access to status updates of messages via the current release note process.



MyStandards News and Releases in the context of T2

- The aim of this presentation is to present some advanced MyStandards features that could provide further guidance to T2 stakeholders who do not have access to the list of MyStandards links and draft T2 EAC release note.
- For instance, Mystandards 'News' functionality is already being used actively by other market infrastructures and could also be used by T2.
- This presentation includes an overview and guidance on MyStandards for:
 - News to announce the delivery of (non-)binding XSDs and message related T2 CRs subject to implementation to members of the RTGS, CLM and CoCo open community.
 - → the content of news would be the same as in the STP, non-binding XSD PDF file and draft T2 EAC release note, i.e. Confirmation of (non-)binding XSD publication with T2 Release indication and T2 CR number(s) and name(s) causing XSD changes for the open community.
 - Releases to allow users to easily find (non)-binding XSDs and usage guidelines for a T2 release.
 - users can already filter usage guidelines allocated to a release via the MyStandards search functionality and the business version of each usage guideline.



Added value and cost of targ€t MyStandards News and Releases features

- After provision of News and Releases features on MyStandards, it is expected that all members of the T2 open community will be well informed with:
 - T2 STP that informs about non-binding and binding XSD publication dates, to be found on the ECB website
 - News that inform about actual publication of non-binding and binding XSDs at each STP milestone related to MyStandards publication, to be provided by 4CB (EMC) on MyStandards
 - Dedicated release structure with business versions that facilitates the search for non-binding and binding XSDs for specific releases (e.g. UDFS T2 R2025.NOV, UDFS T2 R2026.JUN), to be provided by 4CB (EMC) on MyStandards. This feature can for instance:
 - → help users understand the nearly simultaneous delivery of non-binding XSDs for T2 R2025.NOV on 13.06.2025 and for T2 R2026.JUN between 17.06.2025 and 08.07.2025
 - ➔ provide easy access to the underlying HVPS market practice and ISO 20022 base messages of changed T2 XSDs thanks to the tab "Base Standards"
- Also T2-WG and T2-CG members will receive direct information after log-in on MyStandards. However, it should be noted that a facilitated access to binding XSDs on MyStandards does not substitute to the draft T2 EAC release note that contains precise information about changed XSDs (for instance, full collection is published on MyStandards whereas specific XSDs contained in the collection are updated).
- For 4CB, provision of the above additional MyStandards features, despite **costing around 7.000 € per Release**, will most likely reduce the number of inquiries after publication of non-binding and binding XSDs since MyStandards users will receive proactive T2 information on their homepage.
- 4CB will conduct a pilot for T2 R2025.NOV and T2 R2026.JUN and will inform afterwards about the feedback received by the open community.







- T2-CG is invited to take note of the T2 pilot for provision of MyStandards ,Releases' and ,News' features in view of non-binding and binding XSD delivery for T2 R2025.NOV and T2 R2026.JUN.
- 4CB will inform afterwards about the feedback received by the open community. If T2 pilot is successful (i.e. a reasonable amount of questions after delivery of non-binding and binding XSDs is received), the provision of these features could be continued as of T2 R2026.NOV.

'Releases' purpose:

- Provides information about release contents at a glance.
- "Releases" include details on ISO 20022 messages used, message versions and market practice adopted, if any.
- MyStandards does facilitate collection, maintenance and sharing of all information.

Releases appear on the homepage of each group or subgroup.

How to use News as a MyStandards end user







• The 'News' feature in MyStandards allows the publisher to release some 'news', for instance:

News

- Announcement of a change in a Usage Guideline and related T2 CR number;
- Announcement of a new UDFS release;
- Announcement of a delivery of non-binding XSDs;
- Announcement of a delivery of binding XSDs
- The user can see the News in 2 different places: on the home page of the group itself, or in his/her homescreen, when logging on to MyStandards. See both examples in the next slides
