Reason for change and expected benefits/business motivation:

The parameter type value for the System User Reference in the message subscription rule specified by the Change Request T2S-0513-SYS (Adding new message subscription parameter types for Business Sending Party, Instructing Party and Business Sending User) was not in line with the value implemented in the Data Migration Tools and needs to be amended.

Description of requested change:

The value of the parameter type for the System User Reference in the message subscription rule in the Data Migration Tool for message subscription should be updated. The correct value should be 'BUSE' and not 'SURE'.
